#### **Statement of Faith**

Joung Chul Lee

I believe in one Triune God. God is good, eternal, and omnipresent. God seems invisible, but reveals God's self in various ways: in our bodies, natures, relationships, and events. God creates us, saves us, and lives with us. God is, therefore, three in person—Creator, Savior, and Counselor—but one in essence.

I firmly believe that Jesus Christ truly saves us. His salvation is one time work yet eternal reconciliation between God and human beings. Salvation is never earned by our effort but by the work of Christ alone. Good works based on love are essential in Christian life, but insufficient for salvation, which is possible only by the body and the blood of Christ.

The Bible, the Old and New Testaments together, manifests in who God is, what God wants, and why we believe in God. The Bible had been written by those who were caught by God's inspiration over centuries. This book does not require addition or reduction. The Bible is not simply the book of information but the book of life, comfort, wisdom, and discipline.

I believe that the Church is the holy gathering of believers. As we gather, we become the body of Christ. As our body functions successfully when its parts are accordingly connected, so the Church, the body of Christ, works well when we are accordingly connected and cooperate with one another.

I believe that two Sacraments, Baptism and Communion, are crucial in our spiritual lives. Believers experience the forgiveness of sin and participation in Christ's death and resurrection through Baptism, which needs to be done once in a life time. Believers are reminded of Christ's passion, love, and work of reconciliation by Communion. The bread and wine used in Communion are symbols, but provides true experience of Christ.

I believe that human beings are called to love God and neighbors. They, loving God and loving neighbors, are the inseparable missions, for loving neighbors is loving God and loving God is impossible without loving neighbors. Sanctification is to discipline ourselves to be more loving persons, regardless of situations, experiences, and knowledge.

My name is Joung Chul Lee. I will be serving as a Visiting Assistant Professor of Practical Theology, Education, and Spiritual Formation at Pacific School of Religion (PSR) from July 2017. I will also be serving as the Director of Asian and Pacific Islanders Program and taking part of the ministry of Word and Sacrament at campus worship services. Outside the campus, I am serving as a board member of the Confluence Institute, a non-profit organization for Asian American Ministry.

My education background includes BA in Theology at Yonsei University (Seoul, Korea), MDiv at Emory University, ThM at Princeton Theological Seminary, and PhD at Claremont School of Theology. Academically, I am interested in philosophical and theological reflection on religious practice and its relation to formation and transformation. My doctoral dissertation is about interreligious learning and education.

I have been a member of the Presbyterian Church (USA) since 2007. I currently hold membership at the Presbytery of Greater Atlanta, where I finished my inquirer and candidate stages. I did my final assessment in 2011, and am at the stage of the "ready-to-receive-a-call" since then.

I have served multiple churches as preacher, educator, administrator, and musician, during the last ten years. From 2007 to 2010, I served as the director of the young adult ministry at Korean Community Presbyterian Church of Atlanta (PCUSA) and was responsible for education, administration, and music of the group for three years. After that, I went back to Korea and served Oryun Community Church, one of the mega churches in Seoul, Korea, as a worship director of the English worship service. I came back to the States in 2012, and joined Together Community Church (CRC) at La Mirada as youth director and spent another three years with weekly preaching and Bible study. And, I have worked closely with the San Gabriel presbytery and its Good Shepherd Presbyterian Church as director of Christian Education. During the past years, I have been committed to multicultural, bilingual, intergenerational, and immigrant ministries.

Currently, I see that my calling is to be a practical theologian, who teaches future church leaders about and with the beauty of religious practices. It is also my calling to guide them academically and pastorally so they can thrive in theological education and their future ministries.

#### **General Summary:**

The Visiting Assistant Professor of Practical Theology, Education, and Spiritual Formation on the PSR faculty is expected to teach courses in practical theology, education, and spiritual formation, including courses in educational methodology and the construction of educational programs and environments for local churches, as well as provide an understanding of the theological, formational and transformational roles of education in faith communities and organizations committed to spiritually rooted social transformation.

#### **Essential Duties and Responsibilities:**

- Teach courses in practical theology, educational ministries, and spiritual formation to an ecumenical and interreligious body of students.
- Participate in PSR community life as member of the faculty involved in teaching, scholarship, student advising, and community life, worship, and service.
- Work with the faculty and staff to shape the spiritual formation of students and to shape the vision and goals of the school.
- Seek opportunities for the development of creative teaching and new forms of delivering theological education and reaching new audiences, including the use of technology and online instruction.
- Contribute to the shared educational mission of the consortium of the Graduate Theological Union
- Attend monthly faculty meetings with voice and vote, guided by the policies and procedures stated in the Faculty Manual.
- Participate in committee work.
- Carry on research and publication.
- Serve the community in ministry of Word and Sacrament through occasional preaching and presiding at the table during campus worship services.
- Serve as part of the pastoral team that provides pastoral care to students.
- Promote the general welfare of the institution.

  - → My job title at PSR is Visiting Assistant Professor of Practical Theology, Education, and Spiritual Formation. I also serve as the Director of the Asian and Pacific Islander Program.
  - → My essential responsibilities include:
    - o Teaching two courses per semester for each of the two years of the appointment;
    - o Being assigned to faculty committees and student advising;
    - o Full participation in faculty meetings with voice and vote.
    - Serve the community in ministry of Word and Sacrament through occasional preaching and presiding at the table during campus worship services.
    - o Serve as part of the pastoral team that provides pastoral care to students.
  - → Terms of compensation (each year):
    - o \$25,000 stipend from LI
    - \$5,000 stipend from PSR
    - o \$30,000 for housing (PSR provides the 3-bedroom campus housing for the first year and pays \$30,000 for the second year, plus \$2,000 relocation fee)
    - \$10,000 for health insurance coverage (from LI) and PSR will pay the excess if occur
    - o \$4,000 for mentors
    - All travel, food, and lodging expenses when traveling to Louisville (three times a year)
    - o Moving fees up to \$8,000
    - Usual additional stipends that PSR faculty receive (i.e., professional development).
  - → The institutions
    - o Both LI and PSR have commitments to this position as described above.

[Note from COM: a copy of the employment letter from PSR was also submitted.]

- b. How the ministry makes use of their theological education.
  - O My previous theological education is essential in my teaching ministry and advising future religious leaders. As I teach and advise those in MDiv, MA, MTS, DMin, and PhD programs, I will use not only my academic knowledge but also pastoral leadership I learned mostly from my MDiv education.

c. How they are (or intend to be) involved in the Presbytery. Minimum standards for involvement in the Presbytery and congregations include:

attendance at three Presbytery meetings per year,
participation in the committee life of the Presbytery and
availability to moderate sessions and preach in congregations.

- o I am willing to do the standards described above. I will also try to do my best to be available for other needs in the presbytery.
- d. The nature of the institution or organization to which they are accountable, the accountability of that structure for fair employment practices, and institutional provisions for insurance accountability. In the case of a person engaged in private practice, evidence of insurance and participation in a professional organization is necessary.
  - It is limited to say the nature of PSR and LI yet, but both are institutions that highly value the issues related to human rights and social justice. They provide full health insurance for me and my family.
- e. The name of the congregation in which they worship and serve.
  - o I have not decided a new home church yet but will soon choose one and be a member of it.

#### <u>Lauren Patrus – Statement of Faith</u>

I believe in a gracious Triune God – one God in three Persons: Lover, Beloved, Love; Mother, Child, Womb; Father, Son, Spirit.

God created everything – that which we can see, that which we understand, and all that is beyond sight and understanding. Humans were uniquely crafted by God to be in relationship with God, and are entrusted with care of all of God's creation, including but not limited to one another.

Perceiving distance between ourselves and God, we confess that we are sinful. Scripture and the Confessions offer a description of sin as an individual condition which alters community – our relationship with God as expressed through our relationship with one another. The act of confession allows us to be ever more available for grace and life in community. God's response to our sin and our confession has always been reconciliation.

Jesus Christ was fully divine and became fully human so that humanity is fully reconciled to the Triune God. In life and in death Jesus was perfectly obedient to God and provided atonement for our sinfulness.

God is present in and among us through the Holy Spirit. The Holy Spirit makes real to us and inspires and enables us to live in response to the depth of God's love and grace.

This story of creation, sin, reconciliation and redemption is articulated throughout the Bible, God's inspired word. God speaks through Scripture to call and claim us, to communicate the great love of the Triune God, and to describe how we may embody grace through our relationships with God, with the church, and with all of creation.

Christ's life is the perfect example of the mission of God. Following Christ's example, the church's mission is the same: to respond to the miraculous love and grace of God by embodying the Word of God.

The church gathers in worship to receive and respond to the Word of God. The church receives the Word of God in the Sacraments of Baptism and the Lord's Supper. The Sacraments are witnesses to grace - visible signs of the divine love that is beyond our vision.

In the Sacrament of Baptism, the one being baptized receives the sign of water to indicate the reception of grace. All who are present at the Sacrament of Baptism have the opportunity to remember their own Baptism, and to contemplate their own forgiveness and renewal, which is given by God, achieved through Christ's life and death, and experienced through the Holy Spirit.

In the Sacrament of the Lord 's Supper, we are invited to experience our God whose very way of being is of sharing life and love. The broken bread and poured wine are signs of Christ's life, given for all.

Nourished by all aspects of worship - particularly the Sacraments and the proclamation of the Word of God - we are invited to discover the activity of God in the world, and to pursue the mission of God as bearers of the image of our Creator and the miraculous, mysterious grace given to us by God, embodied by the life and death of Jesus, made real to us by the Holy Spirit.

#### Lauren Patrus - Bio

If you had asked me when I was a little girl what I wanted to be when I grew up, you would not have received a very clear answer. I would have struggled to put my vague dreams and various interests into something practical. I would have said something about wanting to travel and loving to read. If you were like most of the adults who asked me this question, you would have smiled and nodded and left confused and perhaps a little concerned about my lack of ambition. All the options just felt so boring to me. I've always been a little impractical and idealistic, and I could not reconcile the ways I wanted the world to be, and the way I wanted to be in the world, with any one career.

In college I accidentally took a philosophy of education course during my first semester, which opened my mind to how large the world of education is, and which led me to declare my major as Middle Grades Education, and to eventually teach middle school for six years. Teaching appealed to me because it allowed me to keep exploring and asking questions within the community of my classroom and school. I have become increasingly fascinated with the way we learn, how we make decisions, how culture influences education and learning and viceversa, and questioning what it means to be successful. In the meantime, I continued to be involved with various Christian communities where I could intentionally explore faith and spirituality.

Faith exploration and formation have been a foundation for me throughout my life. I was baptized as a baby, and while we were primarily a Christmas and Easter family, I grew up with the sacred stories of the Bible. In high school my brother and I found a wonderful, supportive youth group at Morrow Presbyterian Church (Morrow, GA) and I became increasingly involved at that church. During my college years I consistently attended and worked for First Presbyterian Church of Rome, GA, and was highly committed to a campus ministry which allowed me a great deal of opportunity to serve in various settings. After graduation I worked for two years as a missionary on the staff of an international Christian school in Vienna, Austria, and upon my return to the states re-engaged with Morrow Presbyterian and eventually served as an elder there. After 6 years of teaching, I joined the staff at First Presbyterian Church of Atlanta as the Director of Elementary and Family Ministries where I was exposed to the various elements of full time parish ministry, and my calling was clarified. My seminary experiences – including wonderful internships, opportunities to encounter Scripture as I never had before, and the chance to hone my skills of writing and preaching - sealed for me that I was, indeed, called to parish ministry.

At this point in my journey I can see how my desire to walk alongside others in spiritual growth, as well as continuing to question, grow, and learn through teaching all ages intersect with the hopes and needs of First Pres San Leandro. I look forward to growing with them, by God's grace and mercy, in the years to come.

#### Statement of Faith - Rev. Jennifer (Jenny) Warner

The Triune God revealed in Jesus Christ is a God-in-relationship. Before we know anything else about God, we know a God who exists in an eternal relationship of freely given love and everflowing mutuality. Created in this relational reality, we were chosen to freely give and receive love, to live in fellowship with God. Sin is then defined as anything that goes against God's intention of love and fellowship. Fallen from our created relational identity, we are caught in cycles of violence and dysfunction created by our refusal of relatedness or that of others and we are unable to return to unbroken relationship with God, others and the world. Faced with this broken relationship, Jesus Christ restores our broken relationship. He exposed our refusal of relationship, demonstrated God's love and brought salvation through his incarnation, life, death and resurrection. The Holy Spirit draws us into fellowship with God by telling the truth about our brokenness, inviting us to die to our sin and to participate in resurrection through repentance, baptism, community with others and God in God's mission of reconciliation in our world.

Scripture and its history are a holy conversation that attempt to make sense of the unfathomable mystery of God and how this God interacts with the realities of life on earth. In this conversation, Jesus is found as the true Word of God, the Wisdom that the Law and Prophets point towards and the embodied hope that God is reconciling all things to Godself. Scripture's authority comes from its authoritative witness to Jesus Christ. We are invited to enter into the conversation of Scripture, find grace and wholeness in our stories, and give all that we are to seeing God's dream of shalom become reality.

The all-encompassing love of God becomes particular in Jesus Christ and in the community that serves as Christ's hands and feet on earth. The church universal is defined by the mission that has been given to God's people from the beginning of time: blessed to be a blessing. We are called in community to deepen our connection to God and open ourselves in radical hospitality to the world. Ever moving in this call between blessed and blessing, we experience the reign of God now as we grow in freedom, joy and wholeness.

We gather as a historic community, listening to the proclaimed Word of God and participating in the sacraments that Christ himself instituted. In baptism, we declare God's grace by signifying our incorporation into Christ and the church. A profound demonstration of grace is when an infant is baptized and declared loved and chosen by God, though they know nothing of it yet. In the Lord's Supper, we are lifted into the presence of Christ, signifying our full communion with Christ demonstrated in the simplest of actions—eating and sharing bread and wine. The rhythm and practice of Word and Sacrament enact and engage the church in the undeserved grace and radical hospitality of God demonstrated in Jesus.

#### Rev. Jennifer (Jenny) Warner Bio

I was born in Concord, California. My parents were active leaders in the Baptist church that we attended as a family and my early life revolved around church life. Along with church, I attended small Christian elementary and high schools. My childhood heroes were the pastors I knew and the missionaries that my parents knew and supported.

I began college as a psychology major, but switched to intercultural studies my junior year. I was bothered by the insular faith of the churches of my childhood and sought a faith that engaged the world outside the boundaries of my youth. When I was 21, the murder of a childhood friend began a period of deep grief and questioning that shifted the trajectory of my faith from certainty to mystery. I graduated from Biola University with a B.A. in Intercultural Studies and Psychology in 1993.

After college, I moved to Budapest, Hungary to work in a mission organization. These years were deeply formative. I loved living in Europe, the daily adventure and challenge of cross-cultural engagement, and seeking to live a life of hospitality and engagement in the expatriate community. I came home to California in 1997 hoping to explore this at home in the U.S.

In 1998, I married Chris. We have two daughters, Audra and Emmy, now 17 and 14. We helped to start an Evangelical Covenant church in Walnut Creek and went through the ups and downs of a new church development. As I took more responsibility on at the church, I began to read more books on theology and church dynamics. I took on official and unofficial leadership positions at our church. I eventually decided to begin theological studies at Mars Hill Graduate School in Seattle (now Seattle School of Theology and Psychology) where I obtained a Certificate in Spiritual Direction. # <u>COM – Validated Ministry Process</u> Rev. Margaret Gelini, April 2017

John Muir Medical Center, Concord CA: Chaplain Residency Program (ACPE). Beginning September 5, 2017 and completed August 31, 2018. This is a full-time chaplaincy program whereby I will be utilizing my gifts as a pastor, developing a great understanding of God's call upon my life, and gaining a greater insight into my own pastoral identity. I will be considered an "independent contractor" \_(self-employed), compensated \$33,000 annually with \$350 medical reimbursement monthly. Upon completion of this program, I will have earned 4 Units. Prior to being ordained (20 years ago), I completed one unit of CPE.

As you may know, I suffered breast cancer in 2014 and needed to undergo surgery, chemo and radiation. One day I was in the pulpit, and the next in the chemo chair; it has been quite a journey for me. I am still under treatment, but given the "cancer-free" diagnosis from my doctors.

This past year, I have been seeking a process by which I could gain a greater understanding of my pastoral call and next steps in my ministry journey. I remembered how important my CPE experience was to me 20 years ago while under care towards my ordination. And, so I began to explore what process might help me with the next steps in my call as a pastor; I believe God has opened-up this residency program for this purpose in my life.

Below are descriptions of the program:

#### CLINCIAL PASTORAL EDUCATION

Clinical Pastoral Education is interfaith professional education for ministry. It brings theological students and ministers of all faiths (pastors, priests, rabbis, imams and others) into supervised encounter with persons in crisis. Out of an intense involvement with persons in need, and the feedback from peers and teachers, students develop new awareness of themselves as persons and of the needs of those to whom they minister. From theological reflection on specific human situations, they gain a new understanding of ministry. Within the interdisciplinary team process of helping persons, they develop skills in interpersonal and inter-professional relationships.

#### WHAT DO THE ESSENTIAL ELEMENTS OF CPE INCLUDE?

The actual practice of ministry to persons:

Detailed reporting and evaluation of that practice

**Pastoral Supervision** 

A process conception of learning

A theoretical perspective on all elements of the program

A small group of peers in a common learning experience

A specific time-period

An individual contract for learning consistent with the objectives of CPE The CPE program must be conducted under the auspices of an ACPE certified supervisor (faculty) attached to an ACPE accredited CPE center.

# WHAT KIND OF THINGS MIGHT BE INCLUDED IN THE INDIVIDUAL LEARNING CONTRACT?

**Pastoral Reflection** - reflection on one's self as person and pastor in relationship to persons in crisis, the supervisor, and peer group members, as well as the curriculum and institutional setting.

**Pastoral Formation** - focus on personal and pastoral identity issues in learning and ministry.

**Pastoral Competence** - deepening and unfolding of competence in pastoral function, pastoral skills and knowledge of theology and the behavioral sciences.

Although I have been absent from Presbytery meetings the past few years, due to my treatments and recovery, I plan to return and serve on a committee soon.

I have been worshipping and participating at Lakeside Presbyterian Church, San Francisco, with my husband and daughter. Chris, my husband, is the interim pastor at the church (4th year), and our entire family has been lovingly welcomed and embraced into this faith community. I feel very blessed to be part of the Lakeside family. I am available to lead services, preach or help in any area of ministry needed at Lakeside Presbyterian Church.

# Statement of Faith Rev. Tim Lane-Bortell

I believe in the Triune God, One God in three persons, Father, Son, and Holy Spirit/Creator, Christ, and Spirit. God fashioned the universe and our Earth with all its inhabitants. God did this out of love and was pleased with the creation. Throughout the ages God has not been distant but has been a continual presence within the creation providing for its creatures.

In the course of creation God created man and woman in God's image. Throughout human history God has continually shown love and faithfulness to humanity, but humanity has not shown the same faithfulness to God. Human beings entered into sin, separating themselves from God and seeking to make themselves like God. I started as an Associate Pastor in a large United Methodist Church in Moline, IL. After my time there I transferred to the Presbyterian Church so that Linda and I could work in the same denomination. I then served as pastor of a small rural Presbyterian Church in Seaton, IL and following that as co-pastor with Linda in a suburban church in the Chicago area. Then moved to Salinas, California where my wife is a native. During that time I was on staff part time as a per diem chaplain at the Community Hospital of the Monterey Peninsula. I also followed a lifelong passion for the outdoors by working as a sea kayaking guide and instructor. In 2005 we moved to Marin for Linda to begin her ministry at Christ Presbyterian Church in Terra Linda. For the past 11 years I have had a variety of part time jobs. I have worked as a substitute teacher for elementary and middle schools in San Rafael, as a sea kayaking guide for Point Reyes Outdoors in Point Reyes Station, as well as doing regular pulpit supply in Redwoods Presbytery. I have not sought full time ministry over the past several years in order to give more attention to our two children. We have a daughter Amber who just completed her freshman year at Knox College in Galesburg, IL and a son Sean who will be a junior in high school.

#### **DRAFT** COM Guideline for:

Temporary Membership in the Presbytery of San Francisco
For a Minister of Word and Sacrament from another denomination
(Please give your feedback on this draft to COM!)

In our quickly transforming world, the landscape of congregations in Presbytery continues to change drastically. Congregations struggle with the adaptive changes necessary to serve as the church of Jesus Christ in the Bay Area. As the Committee on Ministry journeys side by side with our congregations, COM is also constantly adapting to help congregations meet the challenges that they face.

Congregations are shrinking in numbers and finding fewer resources to sustain themselves and especially to compensate a full-time pastor. Some are not able to sustain even a half time pastor and may find that it is very difficult to procure a pastor for less than half time. This is especially true in our racial ethnic congregations. Some turn to non-PCUSA ministers of Word and Sacrament, with the oversight of COM, to help fill the pastoral role. At this time, even if it is a good match, the congregation may not utilize the non-PCUSA ministers for all of the duties of the congregation, including moderating the session. [Per our Presbytery policy, a pastor must be a member of this Presbytery to be granted permission to moderate session in one of our congregations.]

As stated *Book of Order* G-3.0201, the Presbytery will "provide by rule for moderators when the session is without a moderator..." To give full authority to our congregations, while also providing oversight, we propose the following 'rules' which could allow, in certain extraordinary cases, usually for a part-time position, that a non-PCUSA pastor *may* become a temporary member of the Presbytery of San Francisco while he/she serves as a pastor of one of our congregations.

- The session of the congregation must meet with COM, submit rationale for how their circumstances would be helped by the pastor holding temporary membership, and request that COM and Presbytery follow this particular guideline to allow the pastor to moderate session.
- 2. COM must meet with the pastor and approve all credentials, including those required by *Book of Order* G-2.0505: "A minister being considered for appointment by Presbytery as moderator of session shall furnish credentials and evidence of good standing from wherever she/he holds membership. He/she shall submit satisfactory evidence of possessing the qualifications of character and scholarship required of candidates of this church."
- 3. To be appointed as a session moderator, the non-PCUSA minister of Word and Sacrament must first complete the polity training required of candidates or CRE's *and* shadow, for at least one year, a member of Presbytery serving as moderator of session in one of our congregations.
- 4. When the non-PCUSA minister is no longer needed as moderator and/or leaves the service of one of our congregation, the minister will automatically be removed from the rolls and membership in the Presbytery of San Francisco.
