### **COVID-19 Emergency Relief Funds**

The Presbytery has established an emergency assistance fund for our churches financially affected by this pandemic.

#### Guidelines

The Presbytery of San Francisco COVID-19 Emergency Relief Funds will be used to provide emergency aid to eligible churches. This fund may not be available for cases in which long-term financial support is needed. This fund is intended to be used only for issues directly related to the COVID-19 virus. The maximum amount of disbursement shall be \$10,000. The Presbytery may not be able to fulfill all requests as received and strongly encourages our sessions to explore other avenues for relief such as Board of Pension Grants, Presbyterian Disaster Grants, available relief through the C.A.R.E.S. Act, and other Presbytery of San Francisco grants. Churches who were impacted by COVID-19 and do not have the resources to endure this emergency situation will have first priority for emergency grants.

### Eligibility

Only Presbytery of San Francisco churches and new worshiping communities who are currently using their own emergency reserve financial resources are eligible for grants.

#### **Procedures**

- 1. Submit a completed "COVID-19 Emergency Relief Grant Request Form", along with your January- Current 2020 financial information by emailing to covid19grants@sfpby.org
- 2. All requests must be reviewed and approved by the COVID-19 Grant Team. Additional documentation may be requested.
- 3. Ifadditional funds are needed, other than provided through a COVID-19 Emergency Relief Grant, the session agrees to work with the COVID-19 Grant Team to seek financial support from other outside organizations, entities, and agencies, including the Payroll Protection Program (PPP) available under the C.A.R.E.S. Act.

#### **Parameters**

COVID-19 Emergency Relief funds can only be granted for necessities. These needs include, but are not limited to the following:

- Pastor/Clergy Salaries & Benefits
- Programmatic, Administrative, and Facilities Management Salaries
- Congregant Assistance, such as Food, Housing, and Transportation expenses.
- Church Building and Utilities Expenses

COVID-19 Emergency Grant funds **CANNOT** be granted for the following:

- 3rd Party Preschool or Childcare Expenses
- Capital Projects & Pre-existing Property Repair
- Pre-existing Church Debt
- Business Ventures or Investments
